Key Provisions

Declaration of Rights

 Guarantees fundamental rights such as freedom of speech, religion, and assembly

- Prohibits unreasonable searches and seizures.
- Protects the right to bear arms
- Guarantees due process and equal protection of the law

The Legislature

- Establishes a bicameral legislature consisting of the Senate and the House of Representatives
- Defines the powers and responsibilities of the legislature
- Sets rules for the passage and amendment of laws

The Executive Branch

- Creates the offices of Governor, Lieutenant Governor, and Cabinet
- Defines the powers and responsibilities of the Governor
- Establishes the state agencies and departments

The Judiciary

- Establishes a unified court system consisting of the Supreme Court,
 District Courts of Appeal, Circuit Courts, and County Courts
- Defines the jurisdiction and powers of the courts
- Protects the independence of the judiciary

Amendments

The Constitution of the State of Florida can be amended through a process initiated by the legislature or by citizen petition. Amendments must be approved by a majority of voters in a statewide referendum.

Since its adoption in 1968, the Constitution has been amended over 200 times. Significant amendments include those that:

- Established term limits for the Governor and Cabinet members
- Increased the homestead exemption for property taxes
- Established a "right to privacy" in the state constitution
- Authorized the use of medical marijuana
- Banned offshore oil and gas drilling


